



## Here's How to Make Certain Your Animals Meet Code Enforcement Specifications ...

### **Duval County**

- \* Licenses required for dogs and cats renewed annually at tax collector's offices, most veterinarians; proof of rabies vaccination required. Licenses: \$16 per non-altered dog/cat; \$6 per altered dog/cat. Rebate available for altered pets.
- \* Annual rabies vaccination required for dogs and cats; rabies tag display required.
- \* Leash law for dogs and cats; must be contained by leash or carrier when not on personal property.
- \* Jacksonville Beach only: Pets limited to three per household by law.
- \* On the beach: Droppings must be removed, not buried. Jacksonville/Neptune Beaches: Pets permitted on beach before 9 a.m. and after 5 p.m. only and must be on leash. Atlantic Beach: Pets permitted any time but must be on leash and wear Atlantic Beach license tags.

### **St. Johns County**

- \* License not required outside of city limits. City of St. Augustine only: License required for dogs and cats renewed each September at St. Augustine City Hall; proof of rabies vaccination required. Licenses: \$3 per male and spayed female dog/cat; \$5 per non-spayed female dog/cat. City of St. Augustine Beach only: License required for dogs only renewed each September at St. Augustine Beach City Hall; proof of rabies vaccination required. Licenses: \$3 per male and spayed female dog; \$5 per non-spayed female dog.
- \* Annual rabies vaccination required for dogs and cats; rabies tag display required.
- \* Leash law for dogs and cats; must be contained by leash or carrier when not on personal property.

### **Clay County**

- \* Licenses not required.
- \* Annual rabies vaccination required for dogs and cats; rabies tag display required.
- \* Leash law for dogs only; must be contained by leash or carrier when not on personal property.

### **Nassau County**

- \* Licenses required for dogs and cats renewed annually at First Coast Humane Society; proof of rabies vaccination required. Licenses: \$6 per dog/cat regardless of neuter/spay status. City of Fernandina Beach only: \$20 per non-altered dog/cat; \$5 per altered dog/cat.
- \* Annual rabies vaccination required for dogs and cats; rabies tag display required.
- \* Leash law for dogs only; must be contained by leash or carrier when not on personal property.

### **Baker County**

- \* Licenses not required.
- \* Annual rabies vaccinations required for dogs and cats; rabies tag display required.
- \* Leash law for dogs and cats; must be contained by leash or carrier when not on personal property.
